#### 1 Hardware Overview

The TPA3139D2EVM customer evaluation module demonstrates the TPA3139D2 integrated circuit from Texas Instruments. The TPA3139D2 is a 10-W (per channel) efficient stereo digital amplifier power stage for driving two bridge-tied speakers or a single parallel bridge-tied load.




Figure 1. TPA3139D2EVM

Figure 1 shows the TPA3139D2EVM.

#### 2 Operation

This chapter describes the TPA3139D2EVM board in regards to power supply and system interfaces. The chapter provides information about handling and unpacking, absolute operating conditions, and a description of the factory default switch and jumper configuration.

The following sections provide a step-by-step guide to configuring the TPA3139D2EVM for device evaluation.

### 2.1 Electrostatic Discharge Warning

Many of the components on the TPA3139D2EVM are susceptible to damage by electrostatic discharge (ESD). Customers are advised to observe proper ESD handling precautions when unpacking and handling the EVM, including the use of a grounded wrist strap at an approved ESD workstation.

#### **CAUTION**

Failure to observe ESD handling procedures may result in damage to EVM components.

### 2.2 Unpacking the EVM

When opening the TPA3139D2EVM package, ensure that the following item is included:

A 1-piece TPA3139D2EVM board using one TPA3139D2

If either of these items is missing, contact the TI Product Information Center nearest you to inquire about a replacement.

### 2.3 Power Supply Setup

A power supply is required to power up the EVM. Because most of the pins are PVCC compliant, the PVCC supply can also be used to power the analog supply (AVCC) and can be used to pull up the logic pins for shutdown (SD) control, and fault detection (FAULT). Table 2 lists the power requirements.

#### **CAUTION**

Applying voltages above the limitations given in Table 2 may cause permanent damage to hardware.

### 2.4 EVM Preparations

Complete the following steps to prepare the EVM for use:

- 1. Ensure that the external power source is set to OFF.
- 2. Connect the external regulated power supply adjusted from 3.5 V to 14.4 V to the module PVCC and GND banana jacks, taking care to observe marked polarity.

#### 2.5 Inputs and Outputs

Use the following connection instructions for BTL or PBTL configuration:

1. For a BTL configuration, connect loads across the outputs (OUTL+ and OUTL-) and (OUTR+ and OUTR-).

2. For a PBTL configuration, connect a single load from one of the left speaker jacks to one of the right speaker jacks depending on how the filters are loaded. Apply a single input, differential or single-ended, to the RIN RCA phono plug and tie LINP and LINN directly to Ground (without capacitors).

### 2.6 Power Up

Complete the following steps to power up the EVM board:

- 1. Select the desired gain and mode of operation through J13 (OUT = 26 dB, IN = 20 dB) and J14 (OUT = Low Idle Current, IN = BD).
- 2. Configure the input mode using J6 and J10 (OUT = differential input mode, IN = single-ended input mode).
- 3. Verify the correct voltage and input polarity and set the external power supplies to ON. The EVM should begin operation.
- 4. Adjust the audio source for the correct volume.

### 2.7 Recommended Setting

Table 3 and Table 4 list recommended settings for conditions with BTL (stereo output) and PBTL (mono output), respectively.

- Single-ended input, auto-recover, BTL (stereo output) (see Table 3)
- Single-ended input, auto-recover, PBTL (mono output) (see Table 4)




Figure 2. TPA3139D2EVM Top Composite Assembly






Figure 3. TPA3139D2EVM Bottom Composite Assembly




Figure 4. TPA3139D2EVM Schematic
